

CANCELLATION (CT5)

Apply Cancellation CT5

1. Any respondent of CT1 with under section 31 of the Act which has been won by Applicant will be able to apply CT5.
2. The Respondent must be the Applicant of the CT1.
3. The applicant can select only 1 ground of cancellation.
4. If the applicant is not Malaysian, he has to appoint local representative.
5. Go to Maintain Copyright Tribunal and select Cancellation (CT5), a page as below appeared.
