


QUESTION OF LAW (CT6)

Apply Question of Law CT6

1. A question of law can be raised by any party during the Hearing of a CT application (CT1 to CT6). They will be able to submit this question of law in SPHI and suspend the Hearing.
2. Only the Applicant or the Respondent of the targeted CT can submit a question of law.
3. Only CT application in the process of Hearing possible to submit CT6.
4. Go to Maintain Copyright Tribunal and select Cancellation (CT6), a page as below appeared.


